ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance

be amended by changing all the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 11-1 in the area bounded by

a line 252.14 feet north of and parallel to West Irving Park Road; North California Avenue; a line 228.32 feet north of and parallel to West Irving Park Road; and the alley next west of and parallel to North California Avenue,

to those of a RM-4.5 Residential Multi-Unit District and a corresponding use district is

hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
