RESIDENTIAL PERMIT PARKING

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 090, of the Municipal Code of Chicago, portions of the below named streets are hereby designated as Residential Permit Parking Zones, for the following locations:

WARD	RESIDENTIAL PERMIT PARKING:
23	5500 block of S. Parkside Avenue (both sides) of the street from W. 56th Street to the first alley north thereof; Residential Permit Parking Zone, at all times [Or2013-480]
27	720-796 W. Scott Street (north side), Residential Permit Parking Zone 1055, all times, all days [02013-9408]
WARD	AMEND RESIDENTIAL PERMIT PARKING ZONES:

_	3441-3449 S. Giles Street; Repeal Residential Permit Parking Zone by striking the above (Signs already removed) [02013-6565]

1000-1150 blocks of W. Leland Avenue (both sides) [Or2013-720]
