ORDINANCE The University of Chicago Acct. No. 43697 - 107 Permit No. 1129766

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to The University of Chicago, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, fourteen (14) Irrigation System(s) under the public right-of-way adjacent to its premises known as 5757 S. University Ave..

Said Irrigation System(s) at S. University measure(s):

Two (2) at twelve point five (12.5) feet in length, and point zero eight (.08) feet in width for a total of two (2) square feet. Two (2) at seventy-two point five (72.5) feet in length, and point zero eight (.08) feet in width for a total of eleven point six (11.6) square feet.

Said Irrigation System(s) at S. Woodlawn measure(s):

Two (2) at ninety-six (96) feet in length, and point zero eight (.08) feet in width for a total of fifteen point three six (15.36) square feet.

Said Irrigation System(s) at E. 58th Street measure(s):

One (1) at fourteen (14) feet in length, and point zero eight (.08) feet in width for a total of one point one two (1.12) square feet.

One (1) at nine point five (9.5) feet in length, and point zero eight (.08) feet in width for a total of point seven six (.76) square feet.

One (1) at sixty-four (64) feet in length, and point zero eight (.08) feet in width for a total of five point one two (5.12) square feet.

One (1) at sixty-two (62) feet in length, and point zero eight (.08) feet in width for a total of four point nine six (4.96) square feet.

Two (2) at ninety-seven (97) feet in length, and point zero eight (.08) feet in width for a total of fifteen point five two (15.52) square feet.

Two (2) at one hundred seventy-seven (177) feet in length, and point zero eight (.08) feet in width for a total of twentyeight point three two (28.32) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and

Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1129766 herein granted the sum of one thousand two hundred (\$1,200.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way. Alderman
