ORDINANCE METRA

Acct. No. 1103424 No. 88386- 13 Permit

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to METRA, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, Occupation of Space for (Parking) on the public right-of-way adjacent to its premises known as 9931-49 S. Walden Pkwy.. Metra provide parking near the depot at the 99th Street station on the Beverly Branch of the Rock Island line. A portion of the parking flow over the property line on the South Walden Parkway right-of-way. Existing occupation of space measure one hundred sixty (160) feet in length and ten (10) feet in width for a total on one thousand six hundred (1,600) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1103424 herein granted the sum of eight hundred twenty-seven (\$827.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 07/19/2012.
