BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District symbols and indications as shown on Map No. 10-F in the area bounded by:

West 43 Street; A line 45.5 feet east of and parallel to South Princeton Avenue; a public alley next south of and parallel to West 43rd Street; A line 69.5 feet east of and parallel to South Princeton Avenue

to those of the RT3.5 Residential Two-Flat Townhouse and Multi-Unit District

SECTION 2. This ordinance takes effect after its passage and due publication.
