### ***ORDINANCE BE IT ORDAINED BY***

#### ***THE CITY COUNCIL OF THE CITY OF CHICAGO:***

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 9-1 in the area bound by

West Roscoe Street; the alley next northeast of and parallel to North Elston Avenue; a line perpendicular to North Elston Avenue lying 412.72 feet southeast of West Roscoe Street as measured along the northeast right-of-way line of North Elston Avenue; North Elston Avenue; and a line perpendicular to North Elston Avenue lying 108.5 feet southeast of West Roscoe Street as measured along the northeast right-of-way line of North Elston Avenue

to those of a C1-2 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

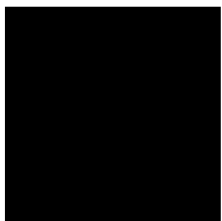
