***IT IS ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance,  
be amended by changing all the RS-3 Residential Single-Unit (Detached House) District  
symbols and indications as shown on Map No. 11-M in the area bounded by

a line 201 feet north of and parallel to West Irving Park Road; a Public Alley 125.21 feet east  
of and parallel to North Marmora Avenue; a line 171 feet north of and parallel to West Irving  
Park Road; and North Marmora Avenue;

to those of an RT4 Residential Two-Flat Townhouse and Multi-Unit District is hereby established in  
the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
