The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs . and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - SignsDepartment of. Planning and Development and Department of Transportation (division of Project Development)." .

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 arid all other required provisions of the Municipal Code of Chicago. -i
