### **ORDINANCE**

WHEREAS, the City of Chicago ("City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to an ordinance adopted on September 5, 2001, and published at pages 66050 through 66055, in the Journal of the Proceedings of the City Council (the "Journal") for such date (the "Ordinance"), as amended by an ordinance adopted on June 19, 2002, and published at pages 88598 through 88603, in the Journal for such date (the Ordinance, as amended, the "Amended Ordinance"), the City has entered into that certain Redevelopment Agreement - African American Showcase of Homes - Phase II (the "Agreement"), dated May 8, 2003, and recorded in the Office of the Recorder of Deeds of Cook County, Illinois (the "Recorder's Office") on May 19, 2003, as document no. 0313702097, with the following individual and entities: (a) Art's Real Estate & Investments, Inc., an Illinois corporation; (b) Fitzgerald Associates, LLC, an Illinois limited liability company; (c) Trey's Movers, Inc., an Illinois corporation; (d) Irma Fortson Ward, an individual; (e) In-Town Properties, an Illinois limited partnership; (f) Le-Na Enterprises, an Illinois partnership; and (g) K & J Developers Corporation, an Illinois corporation (the individual and entities identified in (a) through (g), collectively, the "Developers"); and

WHEREAS, the City and the Developers have entered into that certain First Amendment to Redevelopment Agreement - African American Showcase of Homes - Phase II (the Agreement, as amended, the "Amended Agreement"), dated June 11, 2006, and recorded in the Recorder's Office on July 31, 2006, as document no. 0621218068; and

WHEREAS, pursuant to the Amended Ordinance, and in connection with the Amended Agreement, the City has previously conveyed to Le-Na Enterprises the real property commonly known as 4423 South Vincennes Avenue, Chicago, Illinois, and legally described in Exhibit A attached hereto (the "Vincennes Parcel"), by the City's quitclaim deed (the "City Deed"), dated April 18, 2007, and recorded with the Recorder's Office on April 18, 2007, as document no. 0710831119; and

WHEREAS, Le-Na Enterprises paid the City Five Thousand Dollars (\$5,000) in consideration for the City's conveyance of the Vincennes Parcel; and

WHEREAS, Le-Na Enterprises was obligated under the Amended Agreement and the City Deed to develop residential housing on the Vincennes Parcel; and

WHEREAS, Le-Na Enterprises has not constructed any residential housing on the Vincennes Parcel; and

WHEREAS, Le-Na Enterprises obtained a loan from Dvorkin Holdings, L.L.C., which was secured by a mortgage on the Vincennes Parcel, in the amount of Fifty Thousand Dollars (\$50,000), and recorded with the Recorder's Office on September 23, 2008, as document number 0826729084; and

WHEREAS, Le-Na Enterprises conveyed the Vincennes Parcel to Dvorkin Holdings, L.L.C., pursuant to a quit claim deed dated August 8, 2009, and recorded with the Recorder's Office on March 29, 2013, as document number 1308829084; and

WHEREAS, Dvorkin Holdings, L.L.C., conveyed the Vincennes Parcel to Aaron D and Associates, Ltd., an Illinois corporation, pursuant to a quit claim deed dated March 23, 2016, and recorded with the Recorder's Office on April 11, 2016, as document number 1610216022, and rerecorded (to correctly identify the grantee's corporate structure) with the Recorder's Office on April 18, 2016, as document number 1610944009; and

WHEREAS, Aaron D and Associates, Ltd., proposes to convey the Vincennes Parcel to the City, at no cost to the City; and

**WHEREAS, the City is agreeable to re-acquiring title to the Vincennes Parcel; now, therefore,**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. The above recitals, and the statements of fact and findings made therein, are incorporated herein and made a material part of this ordinance.

SECTION 2. The Commissioner of the Department of Planning and Development ("Commissioner") or a designee of the Commissioner is each hereby authorized, to accept on behalf of the City title to the Vincennes Parcel, and to execute such supporting documents as may be necessary or appropriate in connection with the closing of such conveyance, subject to the approval of the Corporation Counsel.

SECTION 3. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 4. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 5. This ordinance shall be in full force and effect immediately upon its passage and approval.
