ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Cl-1 Neighborhood Commercial District symbols and indications as shown on Map No. 9-J in the area bounded by

A line 80 feet northwesterly as measured along the north easterly line of North Elston Avenue and North Spaulding Avenue perpendicular thereto; North Spaulding Avenue; and North Elston Avenue

to those of a C1-3 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

3661-63 N. Elston AVENUE

The Application is to change zoning for 3661-63 N. Elston, Chicago, IL 60618 from Cl-1 Neighborhood Commercial District to C1-3 Neighborhood Commercial District. The Applicant intends to convert second floor and third floor from two dwelling units, to three dwelling units. There will be six dwelling units in the property, an increase from the current four dwelling units. The building height will remain the same at 38 feet.
