**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the Bl-1, Neighborhood Shopping District symbols as shown on Map No. 7-L in the area bounded by:**

**A line 216.37 feet North of and parallel to West Wrightwood Avenue; North Cicero Avenue; West Wrightwood Avenue; the public alley next West of and parallel to North Cicero Avenue.**

**To those of a Cl-1, Neighborhood Commercial District**

**SECTION 2. This Ordinance takes effect after its passage and approval. Common address of property: 2600-18 North Cicero Avenue, Chicago IL.**
