### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached Housing) District and RM-4.5 Residential Multi-Unit District, as shown on Map 3-G in the area bounded by:

**West Augusta Boulevard, a line 142 feet East of North Ashland Avenue, the alley North and parallel to West Augusta Boulevard and a line 166 feet East of North Ashland Avenue.**

**To those of RM-4.5 Residential Multi-Unit District**

SECTION 2. This ordinance takes effect after its passage and approval.
