ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the CI-2 Neighborhood Commercial District symbols and indications as shown on Map No.13-G in the area bounded by:

A line 91 feet North of and parallel to West Argyle Street; A line 78.50 feet east of and parallel to North Clark Street; West Argyle Street; and North Clark Street.

To those of a C2-2 Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 9, 2020, the undersigned will file an application for a change in zoning from CI -2 to C2-2 on behalf of Applicant CWAZ LLC, for the property located at 5001-5009 N. Clark, Chicago, IL 60640.

The proposed amendment is a change from the current CI-2 zoning district to C2-2 zoning district. Note the

location at 5001 N. Clark is currently operating a Medical and Adult Use Cannabis Dispensary with a CI-2 Neighborhood Commercial District classification. The applicant intends to the expand the current dispensary use into the adjacent storefront, and add an office space which would ultimately have the operation encompass the entire 5001-5009 N.
