ORDINANCE CHICK-FIL-A Acct. No. 360411 - 1 Permit No. 1095701
Be It Ordained by the City Council of the City of Chicago:
SECTION 1. Permission and authority are hereby given and granted to CHICK-FIL-A, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use nine (9) Awning(s) projecting over the public right-of-way adjacent to its premises known as 30 E. Chicago Ave..
Said Awning(s) at E Chicago measure(s):
One (1) at thirty-six (36) feet in length, and five (5) feet in width for a total of one hundred eighty (180) square feet. One (1) at thirty-six (36) feet in length, and five (5) feet in width for a total of one hundred eighty (180) square feet. One (1) at thirty (30) feet in length, and one (1) foot in width for a total of thirty (30) square feet. One (1) at nine (9) feet in length, and ten (10) feet in width for a total of ninety (90) square feet.
Said Awning(s) at N. Wabash measure(s):
One (1) at fifty-five (55) feet in length, and five (5) feet in width for a total of two hundred seventy-five (275) square feet. One (1) at fifty-five (55) feet in length, and five (5) feet in width for a total of two hundred seventy-five (275) square feet. This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.
The grantee shall pay to the City of Chicago as compensation for the privilege #1095701 herein granted the sum of one hundred (\$100.00) per annum in advance.
A 25% penalty will be added for payments received after due date.
The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way Authority herein given and granted for a period of five (5) years from and after Date of Passage.
