Be It Ordained by the City Council ofthe City of Chicago:
SECTION 1. Permission and authority are hereby given and granted to MUSIC AND DANCE THEATER CHICAGO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Drain(s) under the public right-of-way adjacent to its premises known as 205 E . Randolph St..

Said Drain(s) at Lower E. Randolph Street measure(s):
One (1) at one hundred twenty (120) feet in length, and nine point two five (9.25) feet in width for a total of one thousand one hundred ten (1110) square feet. Said trench drain shall be placed in and below the sidewalk approximately twentynine point seven (29.7) feet north of the south line of lower East Randolph Street.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.
