BOARD OF TRUSTEES UNIVERSITY OF ILLINOIS Acct. No.

309115-3 Permit No. 1103195

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to BOARD OF TRUSTEES UNIVERSITY OF ILLINOIS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, five (5) Manhole(s) under the public right-of-way adjacent to its premises known as 1220 S. Wood St..

Said Manhole(s) at S. Wood measure(s):

Two (2) at four (4) feet in length, and four (4) feet in width for a total of thirty-two (32) square feet.

One (1) at seven (7) feet in length, and five (5) feet in width for a total of thirty-five (35) square feet.

One (1) at six point five (6.5) feet in length, and eight point five (8.5) feet in width for a total of fifty-five point two five (55.25) square feet.

Said Manhole(s) at W. Roosevelt Rd measure(s):

One (1) at six point five (6.5) feet in length, and eight point five (8.5) feet in width for a total of fifty-five point two five (55.25) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1103195 herein granted the sum of two thousand (\$2,000.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
