**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1: On behalf of the City of Chicago as Tenant, the Commissioner of the Department of Fleet and Facility Management is authorized to execute a Lease renewal with 3500 Spaulding TMG, LLC, as Landlord, to permit the renewal of the lease agreement for occupancy of 74,549.3 square feet of vacant land located at 3500 North Spaulding Avenue to be used for salt storage by the Department of Streets and Sanitation; such Lease to be approved by the Commissioner of the Department of Streets and Sanitation and approved as to form and legality by the Corporation Counsel in substantially the following form:

**FIRST AMENDMENT TO LEASE**

THIS FIRST AMENDMENT TO LEASE (this "Amendment") dated as of \_\_\_\_\_, 2016 by and between 3500 SPAULDING TMG, LLC, an Illinois limited liability company ("Landlord"), as successor in interest to Spaulding TMG, LLC, and THE CITY OF CHICAGO, an Illinois municipal corporation and home rule unit of government ("Tenant").

**RECITALS**

WHEREAS, Landlord and Tenant are parties to that certain Lease No. 13036 dated March 27, 2014 (the "Original Lease"), for the premises consisting of 131,084 square feet of vacant land located at 3500 North Spaulding Avenue, Chicago, Illinois (the "Original Premises"); and

WHEREAS, the Original Lease was terminated by Landlord effective August 31, 2014 pursuant to communication received by Tenant on June 25, 2014 and reinstated pursuant to Memorandum of Reinstatement dated June 27, 2014 (the Original Lease as amended by the Memorandum of Reinstatement and as amended hereby, the "Lease"); and

WHEREAS, pursuant to the Memorandum of Reinstatement, the Original Premises were reduced to 74,549.3 square feet as depicted on the diagram attached hereto as Exhibit A (the "Revised Premises");

WHEREAS, Landlord and Tenant desire to modify certain terms and conditions of the Original Lease, all on the terms and conditions hereinafter set forth; and

NOW, THEREFORE, in consideration of the mutual covenants of the parties herein and other good and valuable consideration, the receipt and sufficiency of which are hereby mutually acknowledged, Landlord and Tenant agree as follows:

1. Definitions. All capitalized terms used but not defined in this Amendment shall have the same meanings ascribed to them in the Original Lease.

2. Revised Premises; Rent. Landlord and Tenant hereby agree and acknowledge that (a) the total square footage of the Revised Premises is 74,549.3 and (b) the monthly rent payable on account of the Revised

Premises from Tenant to Landlord is \$6,025.00.

3. Term. Landlord and Tenant hereby agree that the expiration date of the Lease is hereby extended to May 31, 2021, unless sooner terminated as set forth in the Lease.

4. Landlord's Address. Landlord hereby notifies Tenant that Landlord's address for purposes of notice and the payment of rent is hereby changed to Spaulding TMG, LLC, 1700 W. Higgins Road, Suite 400, Des Plaines, Illinois 60018.

5. Reaffirmation of Lease. Except to the extent expressly set forth in this Amendment, all of the terms and conditions of the Original Lease shall remain in full force and effect and are hereby ratified and affirmed. If there is any conflict between the terms and provisions of the Original Lease and the terms and provisions of this Amendment, the terms and provisions of this Amendment shall control.

6. Governing Law and Severability. This Amendment shall be governed by and construed in accordance with the laws of the State of Illinois. In the event that any provision of this Amendment shall at any time be found to be invalid or otherwise rendered unenforceable, such provision shall be limited to the extent necessary to render the same valid, or shall be excised from this Amendment, as the circumstances require, and this Amendment shall be construed as if said provision had been incorporated herein as so limited or as if said provision had not been included herein, as the case may be.

7. Counterparts. This Amendment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. This Amendment may be executed and delivered via email or PDF.

8. Effectiveness. This Amendment is not effective unless and until the same is signed and delivered by both Tenant and Landlord.

C.
