401 WEST SUPERIOR HOLDINGS, LLC Acct. No.

421224 - 1 Permit No. 1129563

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 401 WEST SUPERIOR HOLDINGS, LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Vault(s) under the public right-of-way adjacent to its premises known as 401 W. Superior St..

Said Vault(s) at SEGWICK measure(s):

One (1) at seventy-five point five (75.5) feet in length, and eight point eight three (8.83) feet in width for a total of six hundred sixty-six point six seven (666.67) square feet.

Said Vault(s) at W SUPERIOR measure(s).

One (1) at forty-six point five (46.5) feet in length, and eight point eight three (8.83) feet in width for a total of four hundred ten point six (410.6) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination)

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1129563 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
