TRAFFIC LANE - TOW-AWAY ZONE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64 of the Municipal Code of Chicago, the following locations are hereby designated as traffic lane tow-away zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

WARD LOCATION

- 1 W. Wabansia Avenue (south side) from N. Western Avenue to the first alley west thereof - 10-01548186 - PO2010-5375;
- 1 N. Western Avenue (west side) from a point 45 feet north of W. Rice Street to a point 35 feet north thereof, 30 Minute Standing Zone use flashing lights, tow zone after 30 minutes, 8:00 A.M. to 8:00 P.M., Monday through Saturday - 10-01548242 - PO2010-5366;
- 1 N. Paulina Avenue (west side) from a point 20 feet south of N. Milwaukee Avenue to a point 25 feet south thereof, 30 Minute Standing Zone use flashing lights, tow zone after 30 minutes, 8:00 A.M. to 6:00 P.M., Monday through Saturday - 10-01886889 -02010-6267;
- 26 W. North Avenue (south side) from a point 138 feet west of N. Homan Avenue to a point 30 feet west thereof, 30 Minute Standing Zone use flashing lights, tow zone after 30 minutes 9:00 A.M. to 9:00 P.M. - 10-01371557 - PO2010-4898;
- 32 N. Western Avenue (east side) from a point 50 feet north of W. McLean Avenue to a point 35 feet north thereof, 15 Minute Standing Zone use flashing lights, tow zone after 15 minutes 6:30 A.M. to 9:00 P.M. - 10-02037179 - 02010-7072;
- 33 N. St. Louis Avenue (west side) from a point 25 feet south of W. Belle Plaine Avenue to a point 25 feet south thereof, 15 Minute Standing Zone use flashing lights, tow zone after 15 minutes 6:00 A.M. to 7:00 P.M., Monday through Friday - 10-01895533 -02010-6175;
- 35 N. Sacramento Avenue (west side) from a point 32 feet south of W. Diversey Avenue to the first alley south thereof, 15 Minute Standing Zone use flashing lights, tow zone after 15 minutes 6:00 A.M. to midnight, Monday through Saturday - 10-02059962 -02010-7067;

- 49 W. Jarvis Avenue (south side) from a point 170 feet west of N. Sheridan Road to a point 30 feet west thereof, 15 Minute Standing Zone use flashing lights, tow zone after 15

minutes - 10-01576602 -PO2010-5308;

49 N. Ashland Avenue (west side) from a point 255 feet south of

W. Howard Street to a point 43 feet south thereof, 15 Minute Standing Zone use flashing lights tow zone after
15 minutes 7:00 A.M. to 8:00 P.M. - 10-01993230 - 02010-6230;
