### TRAFFIC LANE - TOW ZONES

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane - Tow Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

14	3201-3217 West 51st Street; 3201-3217 West 51st Street (south side) from a point 100 feet east of South Sawyer Avenue to a point 185 feet east thereof; No Parking Tow Zone, 6:00am to 9:00am, Monday through Friday (17-06597511) [02017-7135]
14	5501-5541 South Sawyer Avenue; 5501-5541 South Sawyer Avenue (east side) from a point 125 feet north of West 56th Street to a point 400 feet north thereof; No Parking Tow Zone, 3:00am to 3:00pm, Monday through Saturday -- (17-06597381) [02017-7137]
14	West 47th Street; West 47th Street (south side) from a point 100 feet east of South Spaulding Avenue to South Kedzie Avenue; No Parking Tow Zone, All Times, All Days--(17-06618111) [02017-7138]
29	North Mason Avenue; North Mason Avenue (east and west sides) from West Madison Street to the first alley north thereof; No Parking Tow Zone, 10:00pm to 6:00am, All Days (Public Benefit) -
