SUBSTITUTE ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 2-8-050 of the Municipal Code of Chicago is hereby amended by deleting the language struck through and by adding the language underscored, as follows:

2-8-050 Aldermanic expense allowance.

(Omitted text not affected by this ordinance.)

(b) Expenditures may be made from aldermanic expense allowance funds for any of the following purposes:

(Omitted text not affected by this ordinance.)

(26) Hosting a paper shredding or electronics recycling event, provided that such event is open to the public. Such expense shall not be considered a gift or donation prohibited under subsection (c) of this section:

(264(27) Payment of miscellaneous, ordinary and necessary expenses incurred in connection with the performance of an alderman's official duties.

SECTION 2. This ordinance shall take effect following passage and publication, and shall

apply to expenditures made pursuant to section 2-8-050 beginning September 1, 2019.
