Your Committee on Traffic Control and Safety begs leave to recommend that Your Honorable Body Do Not Pass the sundry proposed ordinances and orders submitted herewith (September 8, November 3, 10, 17, December 8, 2010 and January 13, 2011) concerning traffic regulations and traffic signs, et cetera as follows:
