BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 1 I-I in the area bounded by:

A line 24.14 feet north of and parallel to West Berteau Avenue; North Sacramento Avenue; West Berteau Avenue; and the public alley next west of and parallel to North Sacramento Avenue

to those of a RM-4.5 Residential Multi-Unit District.
