BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

A line 171 feet north of and parallel to West 48th Street; the public alley next west of and parallel to South Damen Avenue; a line 123 feet north of and parallel to West 48th Street; South Damen Avenue,

to those of a BI- 1 Neighborhood Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
