The grantee shall pay to the City of Chicago as compensation for the privilege #1111651 herein granted the sum of sixty-three (\$63.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
