BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RM6.5, Residential Multi-Unit District symbols as shown on Map No. 6-F in the area bounded by:

The alley next north of and parallel to West 22nd Place; a line 150 feet west of and parallel to South Wentworth Avenue; West 22nd Place; a line 175 feet west of and parallel to South Wentworth Avenue.

To those of a B3-5, Community Shopping District
