ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS 3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 3-1 in an area bound by

A line 75 feet East of and parallel to North Washtenaw Avenue, West Augusta Boulevard, a line 100 feet East of and parallel to North Washtenaw Avenue, the public alley next South and parallel to West Augusta Boulevard

to those of an RM 4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.
