ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS2 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-N in the area bounded by:

A line 190.69 feet North of and parallel to West School Street; North Narragansett Avenue; a line 165.55 feet North of and parallel to West School Street; the public alley next West of and parallel to North Narragansett Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District SECTION 2.
