#### **ORDINANCE**

GYU-KAKU RESTAURANT Acct. No.

350215 - 1 Permit No 1118713

#### Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to GYU-KAKU RESTAURANT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Exhaust Duct(s) projecting over the public right-of-way adjacent to its premises known as 210 E. Ohio St..

#### Said Exhaust Duct(s) at Public Alley measure(s):

One (1) at two (2) feet in length, and two (2) feet in width for a total of four (4) square feet. Existing exhaust duct is approximately thirty-seven (37) feet above grade level.

## Said Exhaust Duct(s) at Public Alley measure(s):

Two (2) at two (2) feet in length, and two (2) feet in width for a total of eight (8) square feet. Existing exhaust ducts are approximately twenty-five (25) feet above grade level.

### Said Exhaust Duct(s) at Public Alley measure(s):

One (1) at one point three three (1.33) foot in length, and two (2) feet in width for a total of two point six six (2.66) square feet. Existing exhaust duct is approximately thirty-seven (37) feet above grade level.

the location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1118713 herein granted the sum of one thousand six hundred (\$1,600.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
