MACERICH MANAGEMENT Acct. No.

Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MACERICH MANAGEMENT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, twenty (20) Planter(s) on the public right-of-way for beautification purposes adjacent to its premises known as 43 E. Ohio St..

Said Planter(s) at Grand Avenue measure(s):

Seven (7) at four (4) feet in length, and four (4) feet in width for a total of one hundred twelve (112) square feet. Said

Planter(s) at Wabash Avenue measure(s):

Seven (7) at four (4) feet in length, and four (4) feet in width for a total of one hundred twelve (112) square feet. Said

Planter(s) at Ohio Street measure(s):

Three (3) at four (4) feet in length, and four (4) feet in width for a total of forty-eight (48) square feet. Said

Planter(s) at Rush Street measure(s):

Three (3) at four (4) feet in length, and four (4) feet in width for a total of forty-eight (48) square feet.

Grantee must allow the required clear and unobstructed space for pedestrian passage at all times per rules and regulations approved by the Department of Transportation.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other req	quired
provisions of the Municipal Code of Chicago.	

The grantee shall pay to the City of Chicago as compensation for the privilege #1132947 herein granted the sum of zero (\$.00) per annum in advance.
