BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map Number 11-G in the area bounded by:

North Sheridan Road; a line parallel to and 96.58 feet north of the north line of the right of way of West Sunnyside Avenue; the public alley parallel to and west of North Sheridan Road; and a line parallel to and 46.58 feet north of the north line of the right of way of West Sunnyside Avenue

to those of a to a B2-1 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about October 13, 2017, the undersigned will file an application for a change in zoning from RT-4 Residential Two-Flat, Townhouse and Multi-Unit District to B2-1 Neighborhood Mixed-Use District on behalf of the applicant, 4506 Sheridan, LLC, an Illinois limited liability company, for the property located at 4506 N. Sheridan Road.
