SINGLE DIRECTION

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 010 of the Municipal Code of Chicago, the operator of a vehicle shall operate such vehicle only in the Direction Specified below on the public ways between the limits indicated:

WARD SINGLE DIRECTION:

- 3 South Prairie Avenue; South Prairie Avenue from East Cermak Road to East 21st Street; Single Direction - Northerly [02017-7109]
- 8 9200 South Woodlawn Avenue from East 92nd Street to East 93rd Street; Single Direction - Southerly - (16-00855957) [02016-456]
- 28 3500-3599 West Van Buren Street; 3500-3599 West Van Buren Street from South Central Park Avenue to South St. Louis Avenue; Single Direction - Easterly - (17-00708491) [02017-428]

WARD AMEND SINGLE DIRECTION:

- 8 South Woodlawn Avenue; Amend ordinance Passed 12/06/1961, journal page 5878, which reads: South Woodlawn Avenue from East 79th Street to East 83rd Street; Single Direction - Southerly, by Striking: East 79th Street and Inserting: East 78th Street in lieu thereof-- (17-07153537) [Or2017-544]
- 9 East 102nd Street; Amend Ordinance Passed 09/06/2017, journal page 54994, which reads: East 102nd

- Street from South State Street to South Michigan Avenue; Single Direction - Easterly, by Striking: Easterly and Inserting: Westerly in lieu thereof -(17-07749019) [02017-7874]
- 46 North Racine Avenue; Amend Ordinance Passed 06/09/2010, journal page 93724 which reads: North Racine Avenue from West Wilson Avenue to West Leland Avenue; Single Direction - Northerly, by Striking: West Leland Avenue and Inserting: North Broadway in lieu thereof-- (17-06171593) [02017-6792]
- 15 South Francisco Avenue; Amend Ordinance Passed 07/01/.1970, journal page 8853, which reads: South Francisco Avenue from West 47th Street to West Pershing Road; Single Direction - Northerly, by Striking: West 47th Street and Inserting: the first alley north of West 47th Street [O2017-8650]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
