In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about January 4, 2013, the undersigned will file an application for a change in zoning from B3-2 Community Shopping District to B3-3 Community Shopping District on behalf of Sonco Real Estate LLC 3223 N. Sheffield Series! for the property located at 3223-3229 N. Sheffield Ave.

The applicant intends to redevelop the subject property with a three-story addition above the existing building at the west side of the subject property and a four-story addition linking the building at the west side of the subject property with the buildings at the east side of the subject property to form a single building. The redeveloped, unified building would include commercial space on the first floor and 21 dwelling units on the second through fourth floors. The applicant proposes to include 11 parking spaces to serve the dwelling units at the subject property, which is within 600 feet of the CTA rapid transit station for the Red and Brown Lines on Belmont Ave. The purpose of the zoning change is to permit greater density and a higher floor area ratio at the subject property to accommodate the proposed development. i
