SECTION 1. Pursuant to Title 9, Chapter 64, Section 090, of the Municipal Code of Chicago, portions of the below named streets are hereby designated as residential parking zone, for the following locations:

That the ordinances heretofore passed by the City Council establishing Residential Permit Parking Zones in the 25th Ward in the area with the following boundaries:

- 1800 to 1858 West 17th St. (even side of street), (Zone 1136)
- 1803 to 1859 West 17th St. (odd side of street), (Zone 1136)

Are hereby amended, and this Ordinance establishes that within the aforementioned boundaries, Residential Permit Parking Zone 816, shall take effect upon passage and publication.
