WARD PARKING PROHIBITED AT ALL TIMES - DISABLED:

29 1636 North Mango Avenue, Disabled Permit 116938 [O2018-8898]

WARD RESIDENTIAL PERMIT PARKING ZONES:

17 7849-7857 South Normal Avenue; Residential Permit Parking Zone. Not Recommended [Or2018-389]

18 3700-3757 West 85th Place (north and south sides); Residential Permit Parking Zone. Not Recommended [Or2018-482]

23 5801-5845 South Christiana Avenue (east side); Residential Permit Parking Zone. Not Recommended [Or2018-382]

WARD	TOW ZONES:
42	North Park Drive (west curb) from North Water Street to a point 188 feet north thereof and east curb from North Water Street to East Illinois Street; No Stopping, No Standing, No Parking Tow Zone, All Times, All Days.
