THIS ORDINANCE SHOULD BE USED IN RELATION TO CITY FEES FOR A PERIOD OF TWO YEARS
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Commissioner of the Department of Construction and Permits, the Director of the Department' of Business Affairs and Consumer Protection, the Commissioner of Transportation, the Commissioner of Streets and Sanitation, the Commissioner of the Department of Water Management and the Commissioner of Fire, sre hereby directed to issue ail necessary permits, all on-site water/sewer inspection fees and ali-water/soiwe? plan review fees, frea of charge, notwithstanding other ordinances o: the City of Chicago to the Contrary-io the to tine Swedish Americar* Museum, a not-for-profit Illinois CcfDO. :atlo6. for the erection and maintenance of building {&} and Hie! storage facilities :?t 5211 H. Clark Stresl, Chicago, Illinois 60640.- ''

. Said buildings (s) and all appurtenances thereto ahyil be used exclusively for charitable purposes and shall nor be leased or otherwise used with' arview to profit, and the work thereon shall be oone in accordance with plans submitted - and ail of the appropriate provisions of the Municipal Code of the City of Chicago and departmental requirements of various departments of the City of Chicago, and ? .a<d building is) and all appurtenances thereto shall be constructed and maintained so that they shall comply in all respects with the requirements of the appropriate provisions of the Municipal Code of the City of Chicago for the issuance of all permits and licenses."

SECTION 2. Swedish American fvf-u-seum, a not-for-profit, Illinois Corporation, Located at 5211 hi. Clark Street, engaged in cultural and educational programming and related activities shall be exempt from the payment of City license-fees and shall be entitled so the cancellation of warrants for collection for inspection fees.

SECTION 3. Swedish American Museum shall be entitled lo the refund of City fees which «. has paid and to which it is exempt pursuant ic Section 1 and 2 of this ordinance.

SECTION 4. This ordinance shall be in force for a period from July 1 a 2011 acrtf/nding July 15, 2013
