PUBLIC BUILDING COMMISSION OF CHICAGO Acct. No.: 326701 -

6 Permit No: BACP1585606

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PUBLIC BUILDING COMMISSION OF CHICAGO upon the terms and subject to the conditions, of this ordinance to construct, install, maintain and use one (1) Occupation of Space(s) on the public right-of-way adjacent to its premises known as 2555 W GRAND AVE.

Said Occupation of Space(s) at 2555 W Grand Ave rneasure(s):

One (1) at one hundred sixty-one (161) feet in length and twenty-eight (28) feet in width for a total of four thousand five hundred eight (4,508) square feet.

The location of said privilege shall be as shown on .prints kept oh file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP 1585606 herein granted the sum of Zero (\$0.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
