WHEREAS, Mrs. Mikell has been a dynamic part of the Englewood Community for six decades as a homeowner, participant of the Neighborhood Block Committee, 35-year parishioner of Prayer Tower Church of God in Christ and election judge for the Democratic Party. Mrs. Mikell continues to serve her community by providing clothes and Christmas toys to needy families, and is known for sharing her homegrown vegetables and flowers with her neighbors; and

WHEREAS, Alderman JoAnn Thompson and the 16th Ward of Chicago, wishes to celebrate Etta B. Mikell and

her selfless contributions to the Englewood community; now, therefore
