ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters which pertain to its local government and affairs; and

WHEREAS, the City has determined that the continuance of a shortage of affordable housing to persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City received certain funds from the United States Department of Housing and Urban Development and other sources to make loans and grants to expand the long-term supply of affordable housing through, among other things, acquisition, new construction, reconstruction and moderate and substantial rehabilitation in low- and moderate-income areas; and

WHEREAS, on April 16, 1996, the predecessor department to the City's Department of Housing and Economic Development ("HED") made a loan ("Loan") in the original principal amount of \$4,415,286 to Community Housing Partners III, L.P., an Illinois limited partnership ("Borrower"), the general partner of which is Chicago Community Development Corporation, an Illinois corporation; and

WHEREAS, on April 16, 1996, HED made a separate loan ("Second Loan") in the original principal amount of \$400,000 to Borrower; and

WHEREAS, the Loan was secured by, among other things, that certain Junior Mortgage Security Agreement and Financing Statement dated as of April 16, 1996, made by the Borrower in favor of the City (the "Mortgage"), and the Second Loan was secured by, among other things, that certain Junior Mortgage Security Agreement and Financing Statement dated as of April 16, 1996, made by the Borrower in favor of the City (the "Second Mortgage"); and

WHEREAS, proceeds of the Loan and the Second Loan were used to rehabilitate scattered site housing and related parking lots owned by the Borrower and located at 6545 South Normal, 6547 South Normal, 6553-59 South Normal, 6642-56 South Stewart, 6757 South Parnell, 6850 South Normal, 7001-03 South Normal, 7000-04 South Eggleston/443-45 West 70th Street, 7056 South Eggleston/440-42 West 71st Street, 6816-18 South Perry, 7011-13 South Perry, 7150 South Eggleston/436-44 West 72nd Street, 7008 South Eggleston, 6632 South Stewart, 7049-53 South Eggleston, 7149 South Eggleston, 7151 South Eggleston, 6535 South Normal, and 6858 South Normal, Chicago, Illinois (the "Property"); and

WHEREAS, on April 16, 1996, HED and the Borrower entered into a regulatory agreement ("Regulatory Agreement") imposing affordability restrictions on the housing located at the Property; and

WHEREAS, the Mortgage and the Second Mortgage originally were subordinate to a commercial senior loan, which senior loan Borrower paid off recently; and

WHEREAS, the Borrower now desires to obtain a new senior loan (the "New Senior Loan") to rehabilitate the Property and to pay off the Second Loan, and has requested that the City approve a proposed restructuring of the Loan in a manner which shall cause the Mortgage for the Loan to be subordinated to the mortgage for the New Senior Loan; and

WHEREAS, the City's Department of Housing and Economic Development ("HED") desires to approve a restructuring (the "Restructuring") of the Loan in a manner which (1) will not alter the principal balance of the Loan, (2) will not alter the interest rate on the Loan, (3) will extend the maturity date of the Loan, (4) will alter the repayment terms of the Loan, (5) may extend the affordability restrictions imposed by the Regulatory Agreement, and (6) will subordinate the lien of the Mortgage to a lien securing the New Senior Loan (collectively, the "Material Terms"); now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Restructuring is hereby approved as described above. The Commissioner of HED (the "Commissioner") or a designee of the Commissioner (each, an "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable, in connection with the implementation of the Restructuring. Each Authorized Officer is hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with any future restructuring of the Loan that does not substantially modify the Material Terms.

SECTION 3. Notwithstanding anything to the contrary contained in the Municipal Code of Chicago (the "Municipal Code") or any other ordinance or mayoral executive order, no parties other than the owners of the Property as of the date following the date of the closing of the Restructuring (collectively, the "Owner"), any legal entities which are direct owners in excess of 7.5% of the Owner which changed in connection with the Restructuring, and all legal entities who constitute the direct or indirect controlling parties of the Owner (as determined by the Corporation Counsel), shall be required to provide to the City the document commonly known as the "Economic Disclosure Statement and Affidavit" (or any successor to such document) in connection with the Restructuring.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.
