### TRIBUTE TO THE LIFE OF WILLIAM KING

WHEREAS, Mr. William King's love of life and ability to live it to the fullest endeared him to his family members, friends and all who knew him, and enabled him to enrich their lives in ways they will never forget; and

WHEREAS, William King was an individual of great integrity and accomplishment who will be dearly missed and fondly remembered by his many relatives, friends and co-workers; and

WHEREAS, The Honorable Richard F. Mell, Alderman of the 33<sup>rd</sup> Ward has informed this august body of the passing of his friend, William King; now, therefore
