ORDINANCE

__TT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the C1-1 Neighborhood Commercial District symbols and indications as shown on Map No.7-G in the area bounded by

West Wrightwood Avenue; a line 50 feet east of and parallel to North Wayne Avenue; the alley next south of and parallel to West Wrightwood Avenue; and a line 25 feet east of and parallel to North Wayne Avenue,

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about December 5, 2018, I, the undersigned, filed an application for a change in zoning from a CI-1 Neighborhood Commercial District to a B2-3 Neighborhood Mixed-Use District, on behalf of the Applicant/Owner - Development Group LLC - Wabash, for the property located at 1323 West Wrightwood Avenue, Chicago, Illinois.

The Applicant is seeking a zoning change in order to permit the construction of a new four-story (with basement) all residential building and a detached garage, at the subject site. The existing building will be razed. The new proposed building will contain a total of three (3) dwelling units. There will be vehicular parking for each of the proposed dwelling units located in a new three-car detached garage - at the rear of the lot.
