SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse, and Multi-Unit District symbols and indications as shown on Map No. 16-D in the area bounded by

The alley next west of and parallel to South Harper Avenue; a line 25 feet North of and parallel to East 71st Street; a line 90 feet west of and parallel to South Harper Avenue; And East 71st Street.

to those of a CI-2 Neighborhood Commercial District.
