### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is Residential

hereby amended by changing all of the RT-4 Two-Flat, Townhouse and Multi-Unit District District symbols and indications as shown on Map No. 12-D in the area bounded by East 54<sup>th</sup> Street; South Ingleside Avenue; a line 106.00 feet south of and parallel to East 54<sup>th</sup> Street; a line 104.90 feet west of and parallel to South Ingleside Avenue to those of a RM-5 Multi-Unit District District

SECTION 2. This ordinance takes effect after its passage and approval.


