AMEND LOADING ZONE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

Section 1. That an ordinance passed by the City Council on June 9, 2010 page #93721 of the Journal of Proceedings which reads, West Hubbard Street (north side) from a point 128 feet west of North Clark Street to a point 30 feet west thereof - 15 minute loading zone - use flashing lights - 5:00p.m. to 2:00a.m. (10-00539228), in designated area, be and the same is hereby amended by striking there from, the following:

Section 2. This ordinance shall take effect and be in force hereinafter its passage and publication. 5:00p.m. to 2:00a.m.and inserting in lieu thereof 10:00a.m. to 2:00a.m.
