ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3, Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 9-L in area bound by

North Lavergne Avenue, the public alley next North and parallel to West Dakin Street, North Lamon Avenue, West Dakin Street,

to those of a Bl-1, Neighborhood Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
