BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Chapter 17-17 of the Municipal Code of the City of Chicago is hereby amended by adding the language underscored, as follows:

17-17-0103-N Methadone Clinic. Any facility authorized by the Illinois Department of Public Health to administer or provide the drug methadone in the treatment, maintenance, or detoxification of persons. (Omitted text is unaffected by this ordinance)
