ORDINANCE

WEST LOOP ASSOCIATES LLC Acct. No. 315584 -1 Permit No. 1116468

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to WEST LOOP ASSOCIATES LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Exhaust Duct(s) projecting over the public right-of-way adjacent to its premises known as 550 W. Jackson Blvd..

Said-Exhaust Duct(s) at W. Quincy Street measure(s):

One (1) at five (5) feet in length, and three (3) feet in width for a total of fifteen (15) square feet. Existing exhaust duct is approximately nine (9) feet seven (7) inches above grade level.

One (1) at seven (7) feet in length, and three (3) feet in width for a total of twenty-one (21) square feet. Existing exhaust duct is approximately ten (10) feet above grade level.

The two (2) existing exhaust ducts/stacks are off sets that allow the pipes to exit building under a structural beam and then raise the exhausts to the proper height per coder.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

,~. Said privilege shall be constructed in accordance with plans and specifications approved by the Department of ; transportation (Division of Project Development) and Department of Transportation (Office of Underground • Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1116468 herein granted the sum of eight hundred (\$800.00) per annum in advance.
