### ORDINANCE

#### ***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

SECTION 1. The City Council finds that the areas described in Sections 2 through 5 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-022 (37.57) through 4-60-022 (37.70), as follows:

#### **4-60-022    Restrictions on additional licenses.**

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

- 57)            On the east side of Central Avenue, from West End Avenue to Race Avenue.
- 58)            On West End Avenue, from Long Avenue to Central Avenue.
- 59)            On the north side of Kinzie Street, from Lamon Avenue to Leamington Avenue.
- 60)            On Kinzie Street, from Laramie Avenue to Long Avenue.
- 61)            On Kinzie Street, from Long Avenue to Pine Avenue: and on Corcoran Street, from Pine Avenue to Central Avenue.
- 62)            On Lake Street, from Laramie Avenue to Long Avenue.

- 63) On Lake Street, from Long Avenue to Central Avenue.
- 64) On the south side of Chicago Avenue, from Laverne Avenue to Laramie Avenue.
- 65) On the west side of Laramie Avenue, from Fulton Street to Ferdinand Street.
- 66) On the east side of Pulaski Road, from Lake Street to Ohio Street.
- 67) On Division Street, from Pulaski Road to Keeler Avenue.
- 68) On Division Street, from Keeler Avenue to Kostner Avenue.
- 69) On the west side of Cicero Avenue, from Erie Street to Chicago Avenue.
- 70) On the southwest side of Grand Avenue, from Long Avenue to Central Avenue; and the east side of Central Avenue from Grand Avenue to the southern most centerline of the Soo Line Railroad crossing.

SECTION 3. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by deleting the language struck through and inserting the underscored language, as follows:

**4-60-022 Restrictions on additional licenses.**

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

*(Omitted text is unaffected by this ordinance)*

- (37.29) ~~On the north side of West Chicago Avenue, from North Cicero Avenue to North Lamon Avenue, and on both sides of West Chicago Avenue, from North Lamon Avenue to North Laverne Avenue.~~

- (37.31) ~~On the north side of West Chicago Avenue, from North Laramie Avenue to North Lockwood Avenue, and on both sides of West Chicago Avenue, from North Lockwood Avenue to North Long Avenue.~~

SECTION 4. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023 (37.58) through 4-60-023 (37.72), as follows:

**4-60-023 Restrictions on additional package goods licenses.**

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

- 58) On Division Street, from Avers Avenue to Pulaski Road.
  - 59) On the east side of Central Avenue, from West End Avenue to Race Avenue.
  - 60) On West End Avenue, from Long Avenue to Central Avenue.
  - 61) On the north side of Kinzie Street, from Lamont Avenue to Leamington Avenue.
  - 62) On Kinzie Street, from Laramie Avenue to Long Avenue.
  - 63) On Kinzie Street, from Long Avenue to Pine Avenue; and on Corcoran Street, from Pine Avenue to Central Avenue.
  - 64) On Lake Street, from Laramie Avenue to Long Avenue.

- 65) On Lake Street, from Long Avenue to Central Avenue.
  - 66) On the south side of Chicago Avenue, from Laverne Avenue to Laramie Avenue.
  - 67) On the west side of Laramie Avenue, from Fulton Street to Ferdinand Street.
  - 68) On the east side of Pulaski Road, from Lake Street to Ohio Street.
  - 69) On Division Street, from Pulaski Road to Keeler Avenue.
  - 70) On Division Street, from Keeler Avenue to Kostner Avenue.
  - 71) On the west side of Cicero Avenue, from Erie Street to Chicago Avenue.
  - 72) On the southwest side of Grand Avenue, from Long Avenue to Central Avenue; and the east side of Central Avenue from Grand Avenue to the southern most centerline of the Soo Line Railroad crossing.

*(Omitted text is unaffected by this ordinance)*

SECTION 5. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by deleting the language struck through and inserting the underscored language, as follows:

**4-60-023 Restrictions on additional package goods licenses.**

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

*(Omitted text is unaffected by this ordinance)*

- (37.29) On the north side of West Chicago Avenue, from North Cicero Avenue to North Lamont Avenue; and on both sides of West Chicago Avenue, from North Lamont Avenue to North Laverne Avenue.

*(Omitted text is unaffected by this ordinance)*

(37.31) On the north side of West Chicago Avenue, from North Laramie Avenue to North Lockwood Avenue, and on both sides of West Chicago Avenue, from North Lockwood Avenue to North Long Avenue.

*(Omitted text is unaffected by this ordinance)*
