SECTION 1. Permission and authority are hereby given and granted to CHINA WOK* upon: the termsand subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 1958 W. 35th St.. .> -v

Said Awning(s) at W. 35th Street measure(s): ' < ' • ' :- : iw^rrv?---
One (1) at thirty-one point six six (3T.66) feet in length, and one point six (1.6) foot in width for a total of fifty point six six (50.66) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department-Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1098955 herein granted the sum of fifty-six dollars and sixty-six cents (\$56.66) per annum in advance.
