ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 5-G in the area bounded by

The public alley next south of and parallel to West Armitage Avenue; a southwesterly line 65.30 feet long perpendicular to North Maud Avenue starting at a point 92.30 feet east of the northeast boundary line of North Maud Avenue (as measured along the south line of the public alley next south of and parallel to West Armitage Avenue) and ending at a point 65.41 feet southeast of the south line of the public alley next south of and parallel to West Armitage Avenue (as measured along the northeast boundary line of North Maud Avenue); North Maud Avenue,

to those of
 an RM5 Residential Multi-Unit District.

2. This ordinance takes effect after its passage and approval.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about June 2, 2011, the undersigned, as the owner of the property, will file an application for a change in zoning from RT-4 to RM5 for the property located at 1975 N. Maud Avenue, Chicago, Illinois to increase the maximum allowable Floor Area Ratio to allow for the construction of a 722 square foot, 2 story, 24 foot high, masonry addition to the existing 3 story masonry single family residence. The existing residence currently exceeds the maximum allowable Floor Area Ratio for RT-4 zoning.
